A sociolinguistic insight into its use by non-ethnic speakers
The study investigates the speech of non-ethnic Fulfulde speakers in Northern Cameroon with a special focus on the Christian community of Maroua, where the language is adopted as evangelistic instrument beside French, which is restricted to formally educated people. Three reasons demonstrate the sociolinguistic importance of this case. First Fulfulde is embedded in a multilingual contact situation with Indo-European languages (French, English) and many other local languages belonging to Afro-Asiatic, Nilo-Saharan and Niger-Congo phyla that might have influenced its structure. Second the status of Fulfulde as lingua franca in the region. This status is unique compared to the situation in other countries such as Senegal, Chad or Sudan. Third we are targeting the Christian Fulfulde speakers who share the language as well as the Bible (translated into Fulfulde) as common goods for interethnic communication in their religious activities.

For a long time the Ifa knowledge was kept strictly secret. The Yoruba fortune-tellers, the Babalawo („father of the house of the secrets“), passed the Ifa oracle poems only among themselves. It was not until 1965 that a circle of oracle priests decided to make a part of the knowledge accessible to the public. The illustrated book presents a collection of oracle boards.

Moreover, the underlying conflict ultimately remains unresolved, especially in Eastern Congo in the region of Lake Kivu, where fighting continues between former Hutu units, other militia groups and government troops. In such a context, the search for a “just peace” central, and Bonhoeffer’s peace ethics offer important orientational points of reference.
